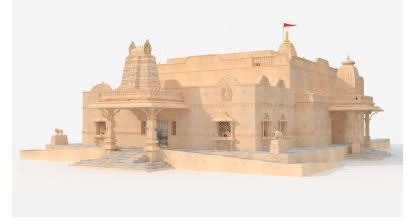


# Hindu Society of North Carolina Triad Hindu Temple Pledge Form
