Triad Hindu Temple Donation and Sponsorship Guidelines

General Guidelines

- Contributions to Hindu Society of NC (Triad Hindu Temple) may qualify as a charitable deduction for federal income tax purposes. Please consult with your tax advisers on how to claim deduction in personal and business taxes
- Triad Hindu Temple is listed under section 501(a) of the internal revenue code as an organization described in Section 501(c)(3) and U.S. Federal Tax ID 58-1379581
- Payments must be received before the end of the year to be eligible for a tax deduction in that year. A certificate of donation/statement will be sent annually to donors
- Cash donations without donor details will be considered anonymous hundi collections
- Triad Hindu Temple is now accepting stock market shares as donation as well






