THT's Construction and Fundraising Updates (November , 2025)**Triad's Dream Temple Occupancy Days Away**

With immense joy and gratitude, we are thrilled to share that **we are less than four weeks away from receiving the Occupancy Certificate** for our long-awaited **Dream Temple**. This has truly been a decades-long journey filled with dedication, faith, and perseverance—and the finish line is finally in sight. We also would like to announce that we have placed order for Statues which would arrive in May. We will do Prana Prathisthapana in June 2026 consecrating our idols. We have raised over 300K this year and we want to finish this year strong raising another 50K in December.

Current Progress

Although the recent delays were mainly due to subcontractor availability, We are working tirelessly, and we remain hopeful of **achieving Occupancy by mid December**. Your encouragement has been our strength during every phase.

Fundraising

Over the last few months, we hosted several fundraising events, and the response has been incredible. Many devotees not only contributed financially but also donated materials essential for construction. **We are deeply grateful for the unwavering support from all corners of the community.**

Over \$300,000 has already been raised this year, and with your blessings, we aim to raise another **\$50,000 in December** to close the year strong. [Fundraising options](#)

Once we receive Occupancy, we will begin the next key phases:

- **Main Śikhara Construction:** \$120,000
- **Interior Indianization of Garbhagrha & Upalayam:** \$150,000
- **Prāṇa Prathisthāpana Ceremony in June 2026:** \$100,000–\$150,000

These are critical steps to complete the sanctum and prepare our temple for divine worship.

***Board Leadership Changes and Removals**

As we continue to grow, **we have also made some operational leadership changes** to ensure we address ongoing issues and challenges effectively. These changes are part of our commitment to strengthening our organizational structure and improving overall efficiency.

Please note: The temple will provide a detailed update on these leadership changes and other operational matters at the **upcoming GBM and Special Meeting** on December 7th.

We are also actively exploring new ways to strengthen recurring operational revenue through **ACH monthly donations and other community-supported initiatives**, and we warmly invite community members to join us in creating sustainable long-term growth.

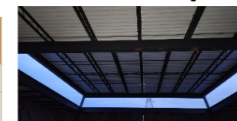
